Public Comment	Les Stapleton announced that pets and owners can have their photos taken with Santa tonight in the MAC at 6:30. Shop with a Cop will take place next Saturday. The characters will be at Archer Park for the Light Display on Friday and Saturday. Tuesday night a corn hole tournament will take place at Jenny Wiley State Resort Park's Dewey's Lounge at a cost of \$5 per person. Turf installation will start next Monday on the infields of the baseball fields. Over \$200k in grants were acquired to start the project and a substantial portion of the labor will be completed by City employees.	
	Jill Hamlin announced that the 2022 APPY's final video product is almost complete. Individuals from Northern Ireland will be flying in to attend the 2023 APPY's on March 18 th . Samantha Johnson announced that Big Sandy Community and Technical College has acquired funds to purchase a new projector for the Science Center.

Monthly Financial Report	Samantha Johnson first presented the October Restaurant/Transient tax collected which is deposited into our Community Trust Bank account. The total amount for October was \$86,903.83 with our portion totaling \$29,829.86. The bills for this month paid out of our People's Bank account totaled \$42,340.35 which includes credit card payment for Rosenberg Square purchases and Veteran Outdoor which are both part of the T-Mobile Hometown Grant, the Tom Whitaker exhibit, Jenny Wiley Festival radio ads. There is also a third check request in this month packet for the mural and reading nook in Rosenberg Square which is post dated for December 30 th , 2022.	Rocky Rowe made motion to approve the monthly financials which Franky Valencia seconded and passed unanimously.
Director's Report	Samantha started by informing the Commission that our marketing is in full Holiday mode. Two more billboards were added with one in Pikeville and one in Allen featuring the Archer Park lights which are up nightly through New Year's Eve. The Kentucky Opry has three more shows this season. On this past Saturday night there were around 650 people in attendance and around four hundred at the Sunday matinee. The SOAR Gala will be held at the MAC in January.	
New Business	Samantha informed the Commission that our winter season Holiday campaigns are on all media sources including radio, digital, geofencing, iHeart Media podcasts, and YouTube ads. We also did another on location weather report from Archer Park.	
	Samantha also told the Commission about the Cincinnati Bike and Trail Expo on March 11th. The cost of a 10x10 booth is \$200. She suggested that two representatives from Sugar Camp Trails and Brooke LeMonds attend the show. We will need to provide food and gas expenses for the representatives along with potential lodging for Brooke.
